TOWN OF BROTHERTOWN CALUMET COUNTY, WISCONSIN ORDINANCE NO.2007- 2

AN ORDINANCE ESTABLISHING RURAL NUMBERING

BE IT ORDAINED by the Town Board of the Town of Brothertown, Calumet County, Wisconsin, as follows: A. NUMBERING SYSTEM All building(s)/structure(s) for residential, commercial, Industrial or other uses in the Town of Brotherown, Calumet County shall be assigned a 911 road number.

B. ASSIGNMENT OF NUMBERS The 911 numbers shall be assigned by the Calumet County Planning and Zoning Department set forth in sections 1 and 2 of Ordinance 1994-1 Calumet County Board of Supervisors. Notification from Calumet County will be sent to the Town of Brothertown, W3880 St. Charles Rd., Chilton, Wisconsin 53014, or via e-mail at brothertown120@ppcws.net.or by fax at 920-849-9008 of the newly assigned 911 number(s).

C. COSTS Cost of the sign, hardware, post, and instsallation fee will be added to the property tax role via special assessment.

- D. INSTALLATION It will be the responsibility of The Town of Brothertown to obtain and install the digital sign after notification is received from the Calumet County Planning and Zoning Department.
- 1.) Installation of the post and sign shall be completed by the Town of Brothertown authorized personnel.
- 2.)Each property is required to display the Town of Brothertown adopted, standardized number provided by the Town.
- 3.) Primary location, all posts are to be installed approximately 18 inches in the ground. All posts are to be installed approximately 15 feet from the edge of the right side of the driveway (facing home from road), and on the back edge of the right of way. Alternate location, same measurements, but left side of the driveway. Alternate location may be necessary due to foliage, lot line boundaries or other obstructions that would compromise the effectiveness of the sign if installed in the primary location.
- E. MAINTENANCE Property owners are responsible to maintain their numbers in a fashion that meets the requirements of this ordinance and subsequent amendments. Failure to maintain their number/post after notification will cause property owner(s) to be subject to the penalty provision identified under section F of this ordinance
- F. PENALTIES anyone who refuses to post, removes, destroys, or alters a sign erected pursuant to this Ordinance shall be subject to a forfeiture of no less than \$25.00 or more than \$200.00 to the Town of Brothertown.

G. REPEALER Any Ordinance no	of wholly in conformity with this Ordinance and contradictory thereto is
hereby expressly repealed. This O	rdinance shall be in effect from and after its passage and proper publication as
required by law. This Ordinance v	vas passed by the unanimous vote of the Town Board of Supervisors at a
