**A RESOLUTION AMENDING THE TOWN OF Brothertown
PREFERRED LAND USE MAP**

WHEREAS, on May 15, 2007, the Calumet County Board of Supervisors adopted the Calumet County Year 2025 Comprehensive Plan in accordance with Section 66.1001, Wis. Stats.; and

WHEREAS, included in the Comprehensive Plan is a Town Land Use Chapter, which includes a Preferred Land Use Map (Map 8-2); and

WHEREAS, Section 66.1001 (2)(i), Wis. Stats. states that a comprehensive plan shall be updated no less than once every 10 years; and

WHEREAS, on 5/23/2011, the Town of Brothertown Plan Commission reviewed the Town of Brothertown Land Use Chapter and Preferred Land Use Map for any updates; and

WHEREAS, the Town of Brothertown Plan Commission, by motion of the commission recorded in its official minutes, recommended the Town Board adopt by resolution the Town of Brothertown Land Use Chapter, including the Preferred Land Use Map, as amended; and

NOW THEREFORE, BE IT RESOLVED, the Town Board of the Town of Brothertown does, by the passing of this resolution, approve the Town of Brothertown Land Use Chapter, which includes the Preferred Land Use Map, as amended.

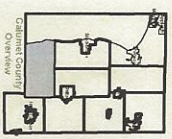

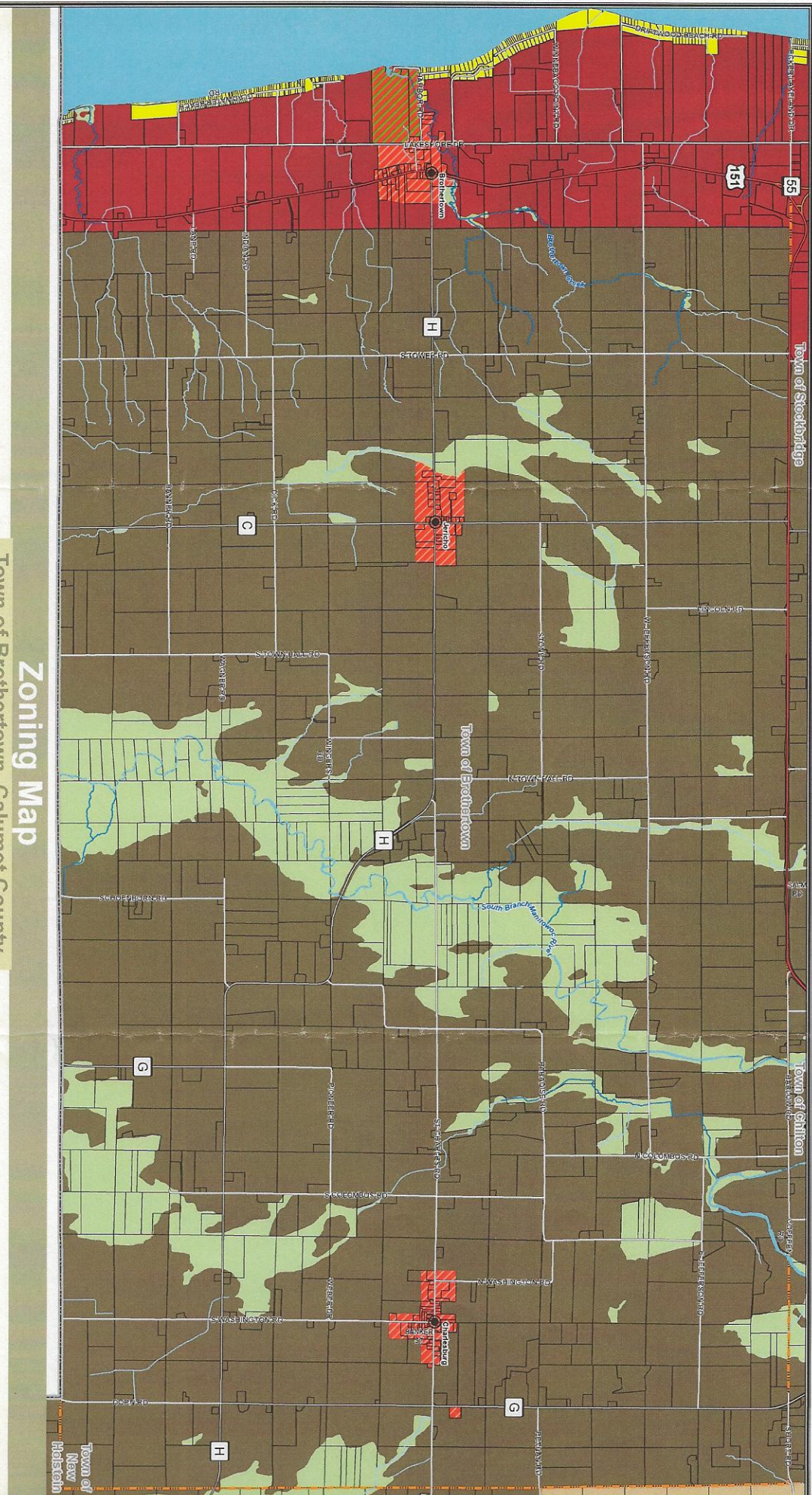
